**Description:** Some 2010, 2011 and 2012 Nissan Altima vehicles may be equipped with an improperly calibrated Engine Control Module (ECM) that, if not repaired, may potentially cause exhaust gas emissions to exceed regulatory standards at high mileage. This incident has no effect on safety, performance, drivability or fuel consumption.

**Remedy:** To correct this condition, Nissan is conducting an Emission Recall Campaign to reprogram the Engine Control Module in your vehicle. This free reprogramming service should take less than one hour to complete, but your Nissan dealer may require your vehicle for a longer period of time based upon their work schedule. To ensure the least inconvenience for you, it is important that you have an appointment before bringing your vehicle to the dealer for service.
